I've received lots of phone calls and letters from families actively involved in working through homeschooling agreements with their districts. Many of these families have not had the chance to get back to me with details of the final "O.K.", and so I'm not able to list their districts as cooperating. I do know that at least a half-dozen other districts were approached about home-teaching over the summer. Hopefully by our mid-winter newsletter we'll have updated information. Many families have also taken the step of simply not enrolling their child in school at all if he or she is under the age of 8. Other have enrolled their children in long-distance private schools. I'd be interested in hearing from any families about the details of their agreements: what was required as far as curriculum write-ups; what, if any, evaluation procedures are expected; if children are using school facilities part time or using any school resources, etc. Especially want to know about use of standardized tests: are they being required, for what stated purposed, administered by whom, and where? Copies of correspondence with school districts are very welcome; many families have been helped by seeing what others have written.
